## What is this product?

**Type:**

The Fund is an Exchange-Traded Fund ("**ETF**") and is a sub-fund of the Company, a company incorporated in Ireland with limited liability as an umbrella type open-ended UCITS investment company with variable capital and segregated liability between its sub-funds under the laws of Ireland with registered number 567964 and authorised by the Central Bank of Ireland.

**Term:**

The Fund has no maturity date. The Fund may be terminated unilaterally by the directors of the Company and there are circumstances in which the Fund can be terminated automatically, as further described in the prospectus.

**Investment Objectives:**

The objective of the Fund is to achieve the net total return performance of the S&P World ESG Enhanced Information Technology Index (the "**Index**"), less fees, expenses and transaction costs.

**Investment Approach:**

The Fund is a passively managed ETF. To achieve the investment objective, the Fund will, as far as possible and practicable, hold all the shares in the Index in their respective weightings.

The Fund is an Article 8 Fund (it promotes environmental and/or social characteristics) for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector ("**SFDR**").

The Fund's base currency is USD.

The Fund may engage in securities lending, whereby 90% of the revenues arising from securities lending will be returned to the Fund and 10% of the revenues will be retained by the securities lending agent.

The Fund may be exposed to the risk of the borrower defaulting on its obligation to return the securities at the end of the loan period and of being unable to sell the collateral provided to it if the borrower defaults.

The Fund may use derivative instruments for the purposes of managing risk, reducing costs or generating additional capital or income.

**The Index:**

The Index is designed to measure the performance of large and mid-capitalisation Information Technologies companies in developed markets and seeks to enhance its ESG profile and reduce its carbon footprint, relative to the S&P World Information Technology Index (the "**Parent Index**"). The Index has been constructed by excluding from the Parent Index, on a quarterly basis, securities that: 1) are involved (according to the Index Provider's criteria) in business activities in tobacco, controversial weapons, oil sands, small arms, military contracting and thermal coal, and 2) are classified as Non-Compliant according to the United Nations Global Compact (UNGC) principles. Securities are also excluded from the Parent Index, on a semi-annual basis, that: 1) do not have a S&P Global ESG Score; (2) do not have carbon intensity data; (3) have an S&P Global ESG Score that falls within the lowest 20% of ESG scores by stock count of the Parent Index; and (4) have carbon intensity levels that rank in the worst 10% of companies by free-float market cap per GICS Industry Group of the Parent Index and in the worst 10% of companies by free-float market cap in the S&P World Index. Involvement and revenue thresholds are defined by the Index provider. Further information in relation to any

revenue thresholds and controversy scoring criteria, can be obtained from the Index provider's website. In addition, securities are also excluded by the Index Provider's Index Committee if they are deemed to face potential ESG risk incidents and/or controversial activities. The Index then applies an optimisation approach to re-weight remaining eligible securities which has the aim of achieving: 1) an uplift in the S&P Global ESG Score; 2) the maximum of either a 30% decrease in carbon intensity relative to the Parent Index or carbon intensity equivalent to the removal of securities that have carbon intensity levels which rank in the worst 25% of companies per GICS Industry Group and in the worst 25% of companies in the Parent Index. These securities are then also subject to turnover constraints. The Index is rebalanced on a semi-annual basis.

Investors should note that the Index is the intellectual property of the index provider. The Fund is not sponsored or endorsed by the index provider and a full disclaimer can be found in the Fund's supplement.

**Dividend Policy:**

This Share Class does not pay you income, but instead reinvests it to grow your capital, in line with its stated objectives.

**Redemption and Dealing of Shares:**

The Fund's shares are listed on one or more Stock Exchange(s). Investors can buy or sell shares daily through an intermediary directly or on Stock Exchange(s) on which the shares are traded. In exceptional circumstances investors will be permitted to redeem their shares directly from Invesco Markets II plc in accordance with the redemption procedures set out in the prospectus, subject to any applicable laws and relevant charges.

**Intended Retail Investor:**

The Fund is intended for investors aiming for long term capital growth, who may not have specific financial expertise but are able to make an informed investment decision based on this document, the supplement, and the prospectus, have a risk appetite consistent with the risk indicator displayed below and understand that there is no capital guarantee or protection (100% of capital is at risk).

Subject to satisfying certain criteria as set out in the prospectus, investors may be able to exchange their investment in the Fund for shares in another sub-fund of the Company which is being offered at that time.

## What are the risks and what could I get in return?

**Risk Indicator**



 The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the ability for you to receive a positive return on your investment.

## What happens if Invesco Investment Management Limited is unable to pay out?

The assets of the Fund are segregated from those of Invesco Investment Management Limited. In addition, the Bank of New York Mellon SA/NV, Dublin Branch (the “**Depositary**”), as the depositary of the Company, is responsible for the safekeeping of the assets of the Fund. To that effect, if Invesco Investment Management Limited defaults, there will be no direct financial impact on the Fund. In addition, the assets of the Fund shall be segregated from the Depositary’s assets, which may limit the risk for the Fund suffering some loss in case of default by the Depositary. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed, in the first year you would get back the amount that you invested (0 % annual return). For the other holding period, we have assumed the fund performs as shown in the moderate scenario and the investment is USD 10,000.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This Share Class has no required minimum holding period however we have selected 5 years as the recommended holding period as the Share Class invests for the long term therefore you should be prepared to stay invested for at least 5 years.

You can sell your shares in the Share Class during this period or hold the investment longer.
