What is this product?

Type

The product is a share class of the Sub-fund Franklin U.S. Equity UCITS ETF (the "Fund") which is part of the Franklin Templeton ICAV (the "Umbrella Fund"), an Irish collective asset-management vehicle constituted as an umbrella fund with segregated liability between Sub-Funds with registration number C167746 and authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to provide exposure to large and mid-capitalisation stocks in the U.S.

Investment Policy

The Fund is passively managed and seeks to track the performance of the Linked LibertyQ US Large Cap Equity Index-NR (the "Index") as closely as possible, regardless of whether the Index level rises or falls. The Fund aims to replicate the Index by holding all its securities in a similar proportion to their weighting in the Index. The Index comprises approximately 200 stocks selected from the Russell 1000® Index-NR (the "Eligible Universe"), using a transparent multi-factor selection process that applies three investment style factors (quality, value and momentum).

Securities in the Eligible Universe are ranked by their composite factor score in descending order. For this, securities with a weight in the Eligible Universe of greater than or equal to 1% are selected for inclusion in the Index first. Then, the top 20% of the remaining securities in the Eligible Universe with the highest composite factor scores are also selected for inclusion in the Index.

The securities in which the Fund invests will be primarily listed or traded on recognised markets globally in accordance with the limits set out in the UCITS Regulations.

The Fund may use derivatives for efficient portfolio management purposes only.

The Fund's shares are listed and traded on one or more stock exchanges. Investors can deal in shares daily through a broker on stock exchange(s) on which the shares are traded. Income from the Fund's investments will be reinvested and not distributed to investors.

Share Class Policy

For accumulation shares, income from investments is reinvested in the Fund and reflected in the price of shares.

Processing of subscription and redemption orders

The Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, only authorised participants (e.g. select financial institutions) may deal in shares directly with the Fund. Other investors can deal in shares daily through a broker on stock exchange(s) on which the shares are traded.

Intended retail investor

The Fund may appeal to investors looking to track the performance of large and mid-capitalisation stocks of the U.S. and who are willing to hold their investment over the medium to long term, for a minimum period of 3 to 5 years. The Fund may be suitable for investors who do not have specific knowledge and/or experience of financial markets and who understand that they may not get back the full amount invested in the Fund.

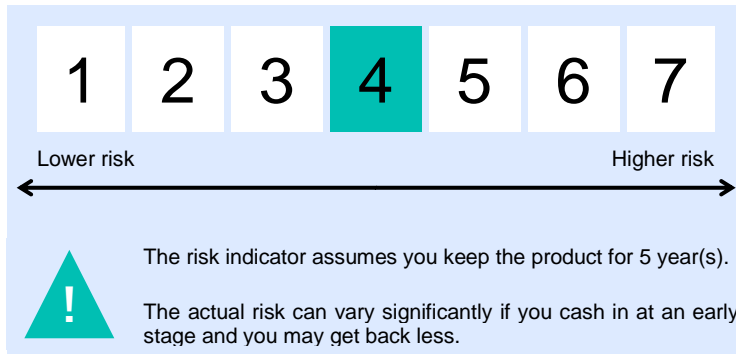

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depository. State Street Custodial Services (Ireland) Limited, as the appointed depository of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depository or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depository.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
