Objectives and investment policy

The fund is passively managed. **INVESTMENT OBJECTIVE:** The fund aims to reflect the performance of the MSCI Emerging Markets Select Sustainability Screened CTB Index (index). **DESCRIPTION OF INDEX:** The index is designed to reflect the performance of large and medium capitalisation companies across global emerging markets which are selected and weighted with the aim of meeting the minimum standards of the EU Climate Transition Benchmarks (EU CTB). **ESG CRITERIA:** The index first removes companies from the MSCI Emerging Markets Index (parent index) which do not meet certain environmental, social and governance (ESG) criteria, as disclosed in the prospectus and/or supplement. Securities from the parent index that are not removed in accordance with the ESG exclusions will constitute the eligible universe. Securities from the eligible universe are selected and weighted following an optimization-based approach which uses their market capitalisation as a starting point, based on constraints and objectives. Securities in the index are subject to climate and other environmental or social objectives constraints, according to the thresholds determined by MSCI, to ensure the minimum standards of EU CTB are met and certain other objectives are met, including a minimum reduction in water emissions intensity and hazardous waste intensity compared to the parent index, a minimum weighted average company revenue in activities deemed as having a sustainable impact, a minimum increase in the weight of companies setting decarbonisation targets, and a maximum weight in securities with lower MSCI ESG Ratings. Securities in the index are subject to

diversification constraints to ensure diversification and representativeness compared to the parent index. **INDEX REBALANCING, CALCULATION AND ADMINISTRATION:** The index is administered by MSCI Limited. The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed and rebalanced on a semi-annual basis. The index is calculated in USD on a daily basis. **INVESTMENT POLICY:** To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 2 per cent. The currency of the fund is USD. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. The following risks could be of particular significance for the fund: The fund will attempt to replicate the performance of the index less costs, but your investment is not expected to match the performance of the index precisely. **EXCEPTIONAL CIRCUMSTANCES RISK:** Exceptional circumstances may arise, such as, but not limited to, disruptive market conditions, additional costs/taxes or extremely volatile markets, which may cause the fund's performance to be substantially different from the performance of the index. **CONFLICTS OF INTEREST RISK:** DWS entities and related companies may act in several roles in relation to the fund such as distributor and management company which may involve conflicts of interest. **NO GUARANTEE RISK:** The fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up. **SHARES RISK:** The value of an investment in shares will depend on a number of factors including, but not limited to, market and economic conditions,

sector, geographical region and political events. **EMERGING MARKETS RISK:** The fund is exposed to less economically developed economies (known as emerging markets) which involve greater risks than well developed economies. Political unrest and economic downturn may be more likely and will affect the value of your investment. **SUSTAINABILITY RISK:** The ESG screening and weighting criteria are embedded within the index selection process, which seeks to exclude securities issued by companies involved in certain activities and overweight securities issued by companies meeting certain standards. The investment manager and sub-portfolio manager are not responsible for monitoring the screening and weighting process or confirming that all securities which pass the screening process are issued by companies with adequate ESG standards. The company is relying on the activities conducted by and information provided by the administrator of the index for the ESG screening and weighting. ESG information from third-party data providers may be incomplete, inaccurate or unavailable. As a result, there is a risk that the index administrator may incorrectly assess a security or issuer, resulting in the incorrect inclusion, exclusion or weighting of a security in the index. Whilst the index seeks to ensure alignment with all EU CTB requirements at each rebalance date, between these rebalances limits may be breached and relevant targets may not be reached. **DERIVATIVES RISK:** The fund may use derivatives to try to manage its investments more efficiently. This may not always be successful and may result in greater fluctuations in the value of the fund. This may negatively affect the value of the fund and your investment.

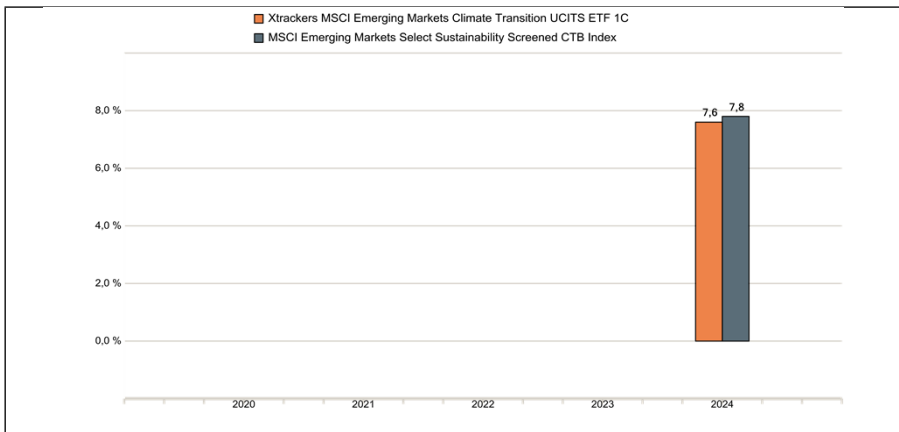
