Objectives and investment policy

The fund is passively managed. **INVESTMENT OBJECTIVE:** The aim is for your investment to reflect the performance of the Euro STOXX® QUALITY DIVIDEND 50 index (index) which is designed to reflect the performance of 50 high quality, high dividend-paying and low volatility shares within the Euro STOXX® index (Base index). **DESCRIPTION OF INDEX:** The shares are selected using a screening process which involves analysing data for each constituent (such as levels of dividends paid out, volatility and income growth rates). Scores are allocated to the universe of eligible constituents based on predefined metrics. The final 50 constituents are selected (with a maximum of 15 per industry) and weighted subject to a 4% cap per constituent. **INDEX REBALANCING, CALCULATION AND ADMINISTRATION:** The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed on a semi-annual basis. **INVESTMENT POLICY:** To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a

substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). The fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the fund. **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is EUR. The fund distributes up to four times per annum. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. 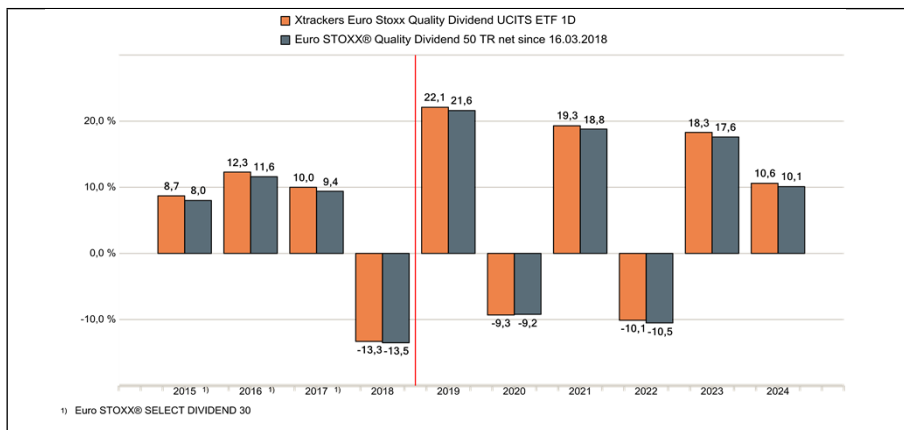
Secondary market investors (those who buy or sell shares on a stock exchange) may be charged certain fees by their stock broker. These charges, if any, can be obtained from such stock broker. Authorised participants dealing directly with the fund will pay the transaction costs related to their subscriptions and redemptions.

The ongoing charges figure is based on expenses for the fiscal year ending 31.12.2024. It may vary from year to year. It excludes portfolio transaction costs and performance fees, if any.

To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 82% of the associated revenue, the securities lending agent, which will be a Deutsche Bank entity, will be allocated 9% and the remaining 9% will be allocated to the DWS entity which monitors such activities, as set out in the sales prospectus and/or supplement, for its own coordination and oversight tasks. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.

Past performance

All costs and fees that were withdrawn from the 1D share class of Xtrackers Euro Stoxx Quality Dividend UCITS ETF were deducted during the calculation. The 1D share class of Xtrackers Euro Stoxx Quality Dividend UCITS ETF was launched in 2007.

As of 16th March 2018 the fund changed its investment objective to reflect the performance of the index. The past performance shown from 2008 to 2017 (inclusive), is that of the Euro STOXX® SELECT DIVIDEND 30 Index. 2018 shows a combined performance of both indices.
