Objectives and investment policy

The fund is passively managed. **INVESTMENT OBJECTIVE:** The aim is for your investment to reflect the performance of the Bloomberg US Long Treasury Index (index). **DESCRIPTION OF INDEX:** The index reflects the performance of sovereign debt denominated in U.S. Dollars with an outstanding maturity of 10 years or greater, issued by the U.S. Government. Only U.S. dollar-denominated, fixed-rate, nominal debt issued by the US Treasury with a maturity of 10 years or greater is eligible for inclusion in the index. In order to be eligible for inclusion in the index, such securities require a minimum amount outstanding of USD 300 million par and must be rated investment grade (Baa3/BBB-/BBB- or higher) using the middle rating of Moody's, S&P and Fitch. Those security issues meeting the criteria described above are included in the index on the last business day of each month (the rebalancing date) with weights based on market value. **INDEX REBALANCING, CALCULATION AND ADMINISTRATION:** The index is calculated on a daily basis using Bloomberg Finance L.P.'s evaluated pricing service, Bloomberg's Evaluated Pricing Product (BVAL). Securities are typically priced at 4.00 p.m. Eastern time. Securities in the index are priced on the bid side. All securities included in the index are quoted as a percentage of their par value. The index is calculated on a total return basis which means that the payments

from coupons are reinvested in the index. The index is administered by Bloomberg Index Services Limited and reviewed and rebalanced monthly. **INVESTMENT POLICY:** To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying a portfolio of securities that may comprise the constituents of the index or other unrelated investments as determined by DWS entities. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. The fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the fund. **FURTHER INFORMATION:** Certain information (including the latest share prices of the fund, indicative net asset values, full disclosure on the composition of the fund's portfolio and information on the index constituents) are available on your local DWS website or at www.Xtrackers.com. Transaction costs and taxes, unexpected fund costs and market conditions such as volatility or liquidity issues may affect the ability of the fund to track the index. The anticipated level of tracking error in normal market conditions is 1 per cent. The currency of the fund is USD. The fund distributes up to four times per annum. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on simulated data that cannot be used as a reliable indicator for the future risk profile. 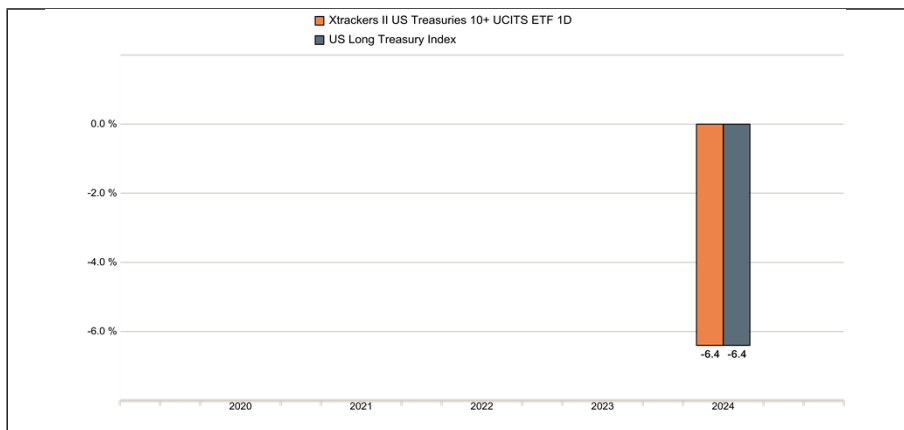

To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 70% of the associated gross revenue. The remaining 30% will be allocated to the management company, out of which it (i) retains 5% of such 30% (that is 1.5% of the overall gross revenues generated from such transactions) for its own coordination and oversight tasks, (ii) pays the direct costs to external service providers, and (iii) pays such revenues as remain following payment of (i) and (ii) to the investment manager for supporting the

management company in initiating, preparing and implementing securities lending transactions, as set out in the sales prospectus. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
